Overview

Established in 2019 with funding from the U.S. Department of Justice, the Council Against Youth Violence (CAYV) addresses violence and victimization among youth in the greater Trenton area. Led by PEI Kids, the regional experts in violence intervention, CAYV uses a multidisciplinary team response model. Together, with our program partners, we deliver targeted victims' services to youth impacted by community violence—specifically, victims, witnesses, or kids who have lost a loved one to violence.

Youth Services

CAYV does not charge for the services provided. They are designed to ensure safety and help victims recover from trauma, grief, and loss—and to reduce the risk of retaliation and/or re-victimization.

We offer the following services* to eligible kids, ages 9–18, impacted by community violence:

- · Mental health counseling
- · Anger management
- Safety planning
- · Emergency shelter
- · GED/High-school equivalency training/testing
- · Academic assistance
- · Job skills and life skills training
- Mentoring
- Family support services
- · Case management
- · Victim compensation assistance
- · Crisis counseling for victims of sexual abuse
- Specialized services for youth with disabilities or complex needs.
- Drug and alcohol assessment, counseling, and recovery support

We accept client referrals through a large network of community partners and organizations, as well as from families, concerned community members, healthcare professionals, justice-system personnel, youth-serving professionals, schools/educators, and faith-based groups.

Community Training

Our leadership team, which has deep community experience and subject-matter expertise, provides training workshops for adults and older teens. Most programs run 60 to 90 minutes and are geared to the needs of specific audiences: parent groups, youth-serving professionals, educators, youth leaders, medical/health professionals, and various other groups. We also offer customized training on specific subject areas like personal safety, youth-violence culture, trauma and mental health, local crime/gang-activity, and effective intervention strategies.
